In view of the above, the issued and paid up equity share capital stands increased to Rs. 13,02,39,279 divided into 13,02,39,279 equity shares of face value of Re. 1/- each.

The Company has already received the in-principle approval in respect of these shares from the National Stock Exchange of India Limited vide its letter no. NSE/LIST/18666 dated October 04, 2018 and BSE Limited vide its letter no. DCS/IPO/JR/ESOP-IP/3245/2018-19 dated October 15, 2018.

The Equity shares allotted shall rank pari-passu and are identical in all respect with the existing equity shares including payment of dividend and other rights.
