# POLICY ON DETERMINATION AND DISCLOSURE OF MATERIALITY OF EVENTS AND INFORMATION

The revised Policy was adopted by the Board of Directors (the "Board") in its meeting held on February 03, 2020 and was made effective from February 12, 2020. This Policy has been further amended by the Board in its meeting held on August 08, 2023.

#### 1. SCOPE AND APPLICABILITY OF THE POLICY

This policy ("**Policy**") of Borosil Renewables Limited ("**Company**") has been adopted in accordance with Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**SEBI LODR**"), which requires every listed company to disclose material events or information to the Stock Exchanges.

## 2. OBJECTIVE OF THIS POLICY

- To determine materiality of an event or information as required under Regulation 30 (4) of SEBI LODR.
- Provide a mechanism for: (i) assisting the employees in identifying any potential reportable/ material event/ information; and (ii) reporting the same to the relevant Authorized Personnel.

#### 3. MATERIAL EVENTS AND DISCLOSURE REQUIREMENTS

- Events specified in Para A of Part A of Schedule III to the SEBI LODR shall be considered material and be disclosed irrespective of application of materiality thresholds;
- Events specified in Para B of Part A of Schedule III to the SEBI LODR shall be disclosed subject to meeting materiality thresholds;
- Any other event/events considered Material by the "Authorized Personnel" shall be disclosed.

## 4. MATERIALITY THRESHOLDS

## **Quantitative criteria**

Quantitative criteria would be calculated based on audited consolidated financial statements and would mean an event / information whose value involved or the expected impact in terms of value, exceeds the lower of the following:

- 2% of turnover, as per the last audited consolidated financial statement of the Company;
- 2% of net worth, as per the last audited consolidated financial statement of the Company, except in case the arithmetic value of the net worth is negative;
- 5% of the average of absolute value of profit or loss after tax, as per the last three audited consolidated financial statements of the Company.

## **Qualitative criteria**

Qualitative criteria would mean:

• the omission of an event or information, which is likely to result in discontinuity or alteration of event or information already available publicly; or

- the omission of an event or information is likely to result in significant market reaction if the said omission came to light at a later date;
- any other event/information may be treated as being material if in the opinion of Authorised Personnel/ Board of Directors, the event / information is material.

## 5. TIMELINE FOR DISCLOSURE OF MATERIAL EVENTS OR INFORMATION

The Company shall first disclose to the Stock Exchanges all events or information which are material as soon as reasonably possible and, in any case, not later than the following:

- (i) thirty minutes from the closure of the meeting of the board of directors in which the decision pertaining to the event or information has been taken.
- (ii) twelve hours from the occurrence of the event or information in case the event or information is emanating from within the Company.
- (iii) twenty-four hours from the occurrence of the event or information in case the event or information is not emanating from within the Company.

Provided that disclosure with respect to events for which timelines have been specified in Para A of Part A of Schedule III of SEBI LODR shall be made within the prescribed timelines.

## 6. AUTHORISED PERSONNEL

In compliance with the provisions of Regulation 30 (5) of SEBI LODR:

- Mr. P.K Kheruka Executive Chairman, Mr. Ashok Jain Whole time Director, and Mr. Sunil Roongta – Chief Financial Officer are severally authorized to determine materiality of an event or information in terms of this Policy.
- Mr. P.K Kheruka Executive Chairman, Mr. Ashok Jain Whole time Director, Mr. Sunil Roongta –
  Chief Financial Officer and Mr. Kishor Talreja Company Secretary and Compliance Officer are
  severally authorized to make disclosures to Stock Exchanges of any material event or information.

## 7. MECHANISM TO IDENTIFY THE POTENTIAL MATERIAL EVENT AND REPORTING

1. The Company Secretary in consultation with the Chairman/ Whole Time Director/ Chief Financial Officer shall communicate the Policy and its requirements to such employees of the Company

(including officers / employees of subsidiaries), whose roles are such that they could have first-hand knowledge of any event that would be a material event for the purpose of this Policy.

- 2. The Company Secretary shall on annual basis communicate the Quantitative Materiality criteria to the aforesaid employees.
- 3. Employees who have the knowledge of potential event (Para A events where materiality is not applicable and Para B where it is applicable) shall forthwith communicate the same to Mr. P.K Kheruka, Mr. Ashok Jain, Mr. Sunil Roongta and Mr. Kishor Talreja.

Mr. Kishor Talreja/ Mr. Sunil Roongta will take guidance as to materiality of the event/ information from Mr. P.K. Kheruka or Mr. Ashok Jain.

4. The list of Events falling under Para A and B of Part A of Schedule III to the SEBI LODR are annexed to this Policy for ready reference and any amendment in the same shall be updated by the Company Secretary from time to time to assist the employees.

## 8. REVIEW AND AMENDMENT OF POLICY

- The Policy shall be reviewed by the Board as and when any changes are to be incorporated in the Policy due to change in regulations or as may be felt appropriate by the Board. However, any change required in the policy due to change in the Authorized Personnel of the Company, the Company Secretary is authorized to incorporate such change in consultation with Mr. P.K. Kheruka, Executive Chairman of the Company.
- In case of any subsequent changes in the provisions of the SEBI LODR or any other regulations
  which makes any of the provisions in the Policy inconsistent with SEBI LODR or any other law, the
  provisions of the SEBI LODR or such other law, would prevail over the Policy. Any amendments
  made in SEBI LODR shall be effective and binding on the Company even if such amendments are
  not incorporated in the Policy.
