1. The Company has locked-in pre-preferential holding of the allottees (promoter as well as public category) under the preferential allotment of equity shares and warrants made on 14th February 2025. Additionally, the equity shares allotted under the preferential issue including those allotted upon conversion of warrants have been locked-in. Further, the pre-preferential shareholding of allottees (public category) under preferential allotment of equity shares made on October 17, 2025 have also been locked-in.

2. Details of holding of warrants and shares of partnership firms (who were allotted warrants and equity shares under preferential issues) are shown under category Resident Individual holding nominal share capital upto Rs. 2 lakhs, as per the information received from depositories.
3. The Company has on October 17, 2025 done the preferential allotment of 69,43,691 equity shares. Apart from these shares, 25,471 shares allotted against warrants conversion and 5,412 shares allotted against ESOP during the quarter ended September 30, 2025, have been shown in physical form, as the process for crediting these shares in demat account of allottees could not be completed as on 17th October 2025.
