- 1. 12,000 equity shares were allotted to eligible employee pursuant to exercise of ESOPs during the quarter ended March 31, 2025.
- 2. On 14th February, 2025, the Company has allotted 18,86,793 Equity Shares to the persons forming part of Promoter/Promoter group and 78,80,436 Warrants (convertible into equity shares) to Non-Promoter investors on a preferential basis.
